## NOTIFICATION

The Department of Food and Supplies has issued the copy of the Bi-Partite Agreement, the contractual agreement to be signed between Food and Supplies Department, Government of West Bengal represented by the District Controller (Food & Supplies) with Rice Mill for Milling of procured Paddy for Kharif Marketing Season (KMS) 2019-20 and the Tri-partite Agreement between the CMR Agency, Co-operative Society and Rice Mill for procurement of paddy for KMS 2019-20.

2. At Part C of the Bi-Partite Agreement and Part B of the Tri-Partite Agreement it has been stated that:-

"The Rice Miller, the party hereto of third part, shall have to furnish security deposit in the form of BANK GURANTEE issued by any Nationalized Bank as per the following norms.

- a) Rice Mill that possess paddy within 3000 MT at any point of time Shall have to furnish an undated cheque amounting to Rs 35, 00,000/-(Thirty Five Lakh) only.
- b) Rice Mill that possess paddy within the range 3000-5000 MT at any point of time Shall have to furnish BANK GUARANTEE of Rs 50, 00,000/- (Rupees Fifty Lakh) only.
- c) Rice Mill that possess paddy within the range 5000-10000 MT at any point of time Shall have to furnish BANK GUARANTEE of Rs 1,00,00,000/- (Rupees One Crore) only.
- d) Rice Mill that possesses paddy more than 10000 MT upto a maximum of 20000 MT at any point of time Shall have to furnish Bank Guarantee at least of Rs 3, 00, 00,000/- (Rupees Three Crore) only".
- 3. Now it has been decided that like previous KMSs the Raw Rice Millers shall have to furnish security deposit in the form of Bank Guarantee of Rs. 50, 00,000/-(Rupees Fifty Lakh) only for participation in procurement but if the possession of paddy of any Raw Rice Mill exceeds 5000 MT, he/ she shall have to furnish Bank Guarantee of Rs. 1, 00, 00,000/- (Rupees One Crore) only for KMS 2019-20 and onwards as per the slabs above. But the Par-boiled Rice Millers shall have to furnish the Bank Guarantee as per the above mentioned slabs.
- 4. This issues with approval of the Competent Authority.
