## **NOTIFICATION**

The State Government had earlier notified 291 (Two Hundred and Ninety One) Centralized Procurement Centres (CPCs) in 1<sup>st</sup> phase for purchase of paddy from the farmers during KMS 2019-20 vide Memo No. 4058-FS/Sectt/Food/4P-16/2016 (Pt.) dated 30.09.2019.

The State Government has now decided to set up 58 more number of CPCs in addition to the existing 291 number of CPCs during the KMS 2019-20.

The Governor is now pleased to decide that a total 58 CPCs out of which 56 are of 2<sup>nd</sup> CPCs and 2 are of additional CPCs will be operationalised by the Department as shown in the table below. The 2<sup>nd</sup> CPCs will run from the beginning of December, 2019 and will continue till the end of April, 2020 and the additional CPCs will run from the beginning of January, 2020 and will continue till the end of April, 2020.

Further each CPC must have the requisite infrastructure like moisture meters, electronic weighing machine, computer desktop /TAB etc., to facilitate procurement of Fair Average Quality (FAQ) paddy. In case the paddy is not lifted by the rice mills in time, adequate facility for temporary storage within the premises of the CPC must be identified to prevent any damage of the procured paddy. Each CPC must have a proper hoarding displaying all relevant information for the farmers including FAQ rice, MSP, documents required for registration etc.
