Distance from Purchase Centres to the tagged Rice Mills		Rate in Rs.
1	For distance up to 25 kms	18. 38/qtl.
2	For distance beyond 25 kms and up to 50 kms	50 paisa /km/qtl.
3	For distance beyond 50 kms and up to 100 kms	20 paisa/kms/qtl.

The concerned Block Food Inspector of the Block and Block Co-operative Inspector will jointly certify the exact distance between the Purchase Centres of the Cooperative Societies and SHGs and the Rice Mills. In case of Farmers Producers Organisation (FPO)/Farmers Producers Company (FPC) the exact distance between the Purchase Centre of the FPO, the concerned Block Food Inspector and the Assistant Director, Agriculture will jointly certify. The District Controllers Food & Supplies and the Sub- Divisional Controllers Food & Supplies shall certify the exact distance between the Centralised Procurement Centres and the Rice Mills for onward processing of claim for additional transport charges by Rice Millers.
