NOTIFICATION

The Government in Food & Supplies Department has notified the Provisional State Cost Sheet (with item wise details) of Custom Milled Rice(CMR) (FAQ) meant for decentralized Paddy Procurement Operation at CPCs/DPC and through the CMR Agencies separately for Central Pool as well as State Pool under the NFSA, RKSY and Other State sponsored schemes during current Kharif Marketing Season(KMS) 2019-2020 vide this Department no. 1506-FS dated 18th May'2020.

- 2. In view of present situation due to the outbreak of COVID-19 and due to closure of Jute Mills resulting into disruption in supply of Gunny Bags, the Government in F&S Department decides purchase of HDPE/PP bags for bagging of CMR through the Government e-Marketplace (GeM) on approval of the Government of India vide no. 15-9/2019-Py.III-Part-II (E/371253) dated 10.04.2020 read with Finance Department, Govt. of West Bengal UO no. Group-A/II/2020-2021/0003 dated 30/04/2020.
- 3. Now, in partial modification of the Notification no. 1506-FS dated 18th May'2020, the acquisition cost as well as the economic cost of CMR for one quintal of CMR, considering the use of HDPE/PP bags in lieu of Gunny bags will be as follows:
