***ORDER***


In view of unprecedented situation on outbreak of COVID-19 pandemic followed by disruption in supply of jute bags due to closure of Jute Mills, there is an acute shortage of new jute bags for bagging of Custom Milled Rice(CMR) in this KMS 2020-21.

To mitigate the constraints in supply of new jute bags by the JCO, it is decided to use the once used jute bags / gunnies for bagging and delivery of pending CMR by the Rice Mills of this State from February'2021, onwards.

The Rice Mills may use single used gunny bags(in good condition) for bagging of CMR(for both Central and State Pool), with a stamping as "Second Use" on the bags. Reimbursement will be given to the Rice Mills, on submission of Bills, duly certified by the SCF&Ss/ADCF&Ss/DCF&Ss, for use of one time/ single used gunny bags @ Rs. 19.50/- per bags (Rupees Nineteen and fifty paise only) as approved by the Finance Department vide U.O. No. Group. A-II/2020-2021/0037 dated 29.10.2020. and U.O. No. 0086/Gr.A-II dated 28.01.2021. Separate Bills are to be submitted by the Rice Mills in this regard to the Director of Finance, F&S Department for reimbursement. District wise allocation on maximum permissible limit on use of once used jute bales is enclosed herewith.

This is issued in interest of procurement and PDS.
