NOTIFICATION

The Department of Food and Supplies had earlier extended the authority given to the District Controller, F&Ss, in enhancing the paddy holding limit of the empanelled Rice Mills against the given Bank Guarantee till 31st March, 2021, vide order no. 792-FNS dated 24th February' 2021.

Since the procured paddy needs to be dispatched to the empanelled and tagged Rice Mills for milling of the same for delivery of Custom Milled Rice(CMR) and since the farmers needs to be saved from distress sale, the relaxation on paddy holding imit as mentioned in aforesaid order dated 24th February, 2021 is further extended upto 30th April, 2021.

However, the paddy holding limit upto double to the amount of the normal paddy holding limit as allowed to the empanelled Rice Mills against the BG submitted on or before 12th November, 2020, vide order dated 24th February, 2021, as mentioned above, will be reduced to the normal limit instead of double, w.e.f. 1st April, 2021.
