
NOTIFICATION

The Department of Food and Supplies in further modification of the earlier issued notification no 2662-FS dated 30th October'2020 on submission of Bank Guarantee (BG) by the empanelled Rice Millers before receiving paddy from the Purchase Centers in KMS 2020-21, state that the Rice Millers, who will submit the BG after completion of delivery of CMR of KMS 2019-20 by 31.10.2020, completion of online applications and signing of the Bi-partite Agreements along with requisite BG by 12th November'2020, will receive triple the amount of paddy equivalent to the BG deposited, till 31st December'2020 as mentioned under point 6 of the notification no 2431-FS dated 30th September'2020 for KMS 2020-21 and against the BG as per table given in point no. 3.

However, the Rice Mills who will sign the Bi-partite Agreement along with requisite BG between 12th November'2020 and 24th November 2020, will receive double the amount of paddy equivalent to the BG as notified earlier.

Furthermore, in partial amendment of the point no. 4 of the notification no. 2431-FS dated 30th Sept'2020, it is hereby further notified that the Raw Rice Millers shall have to furnish compulsory security deposit in the form of Bank Guarantee of Rs. 50,00,000/- (Rupees Fifty Lakhs) only for participation in procurement like earlier KMSs. However, for receiving paddy in excess of 1500 MT, by the Raw Rice Mill shall have to furnish Bank Guarantee of Rs. 60,00,000/- (Rupees Sixty Lakhs) only and so on for KMS 2020-21 as per slabs mentioned in point no. 3 of the notification, mentioned above.


