Sub: Extension of Time to receive Paddy at Enhanced Quantity against BG

The issue of submission of Bank Guarantee and facility of delivery of paddy to Rice Millers against the Bank Guarantee as well as facility of delivery of paddy at the rate of double and triple the normal entitlement against the Bank Guarantee was covered vide Memo No. 2771-FNS dated 11th November 2020.

In response to the notification of the Government to issue paddy against the Bank Guarantee, most of the Rice Millers have submitted Bank Guarantee within due date of 12/11/2020 & 24/11/2020.

Since the benefit of enhanced entitlement during these months could not be fully utilized by the Rice Millers, in order to encourage the empanelled Rice Millers who have complied with the Government guidelines regarding submission of Bank Guarantee during the starting phase of delivery of paddy at the double and triple the normal entitlement against the Bank Guarantee submitted by them, the Governor is pleased to amend the Para 5 and 6 of No. 2771-FNS dated 11th November 2020 like as follows:

- a) The empanelled Rice Millers of KMS 2020-21, who have submitted BG by 12th November, 2020 will be entitied to get triple amount of paddy till 31st January 2021
- b) The empanelled Rice Millers of KMS 2020-21 who have submitted BG by 24th November 2020 will be entitled to get double amount of the paddy, till 31st January 2021

However, the New Rice Mills will be required to submit the BG only for getting the paddy following the table mentioned in point no. 2 of the aforesaid order.

This order is issued with the approval of the Competent Authority.
