In point no. 6 of the aforesaid order dated 30th September'2020, it was stated that the Rice Millers, who will submit the Bank Guarantee (BG) by 15.11.2020 after completion of delivery of CMR of KMS 2020-21 by 31.10.2020 will get the double the equivalent paddy as mentioned in the notification for KMS 2020-21 for the months of November and December 2020 against the BG as per table given in point no. 3.

Now, in partial modification of the point no. 6 of the above mentioned notification, it is hereby stated that the Rice Mills who are showing their willingness and co-operation in completion of their CMR obligations before 31st October'2020, submission of online applications and signing of the Bi-partite Agreements along with requisite BG by 6th November'2020, will receive triple the amount of paddy equivalent to the BG deposited, till 31st December'2020.

However, the Rice Mills who will sign the Bi-partite Agreement along with requisite BG between 7th November'2020 and 15th November 2020, will receive double the amount of paddy equivalent to the BG as notified earlier.
